- 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before 04.00 **P.M. of** 18.11.2024 shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on 19.11.2024 from 01:00PM to 02:00 P.M by way of inter-se bidding amongst the bidders.
