7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price**/s through online mode/DD before 04:00 PM on **30.12.2024** shall be eligible for participating in the e-auction. The e-auction shall be conducted on scheduled date by way of inter-se bidding amongst the bidders.
