- 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.**
- 7) The interested bidders who may have submitted their EMD not below the 10% of reserve price through online mode/DD before 04.00 P.M. of 24.09.2024 shall be eligible for participating in the e-auction.** The e-auction of above property would be conducted exactly on 25.09.2024 from **01.00 P.M to 03.00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.5,000/- (Rupees Five Thousand Only). In case bid is placed in the last 5 minutes of the closing time of the e-auction, the closing time will automatically get extended for **5 minutes** (subject to unlimited extensions of **05 minutes** each).
