## TERMS AND CONDITIONS:

However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of property/ies put on auction and claims/rights/dues affecting the property, prior to submitting their bid. - 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before 04.00 **P.M. of** 09.12.2024 shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on 10.12.2024 from 02:00 **PM to 03.00 P.M** by way of inter-se bidding amongst the bidders.
