#### HOW TO SUBMIT THE TENDER:

### **Registration Process.**

- a. Bidder should do registration/enrolment via the e-tendering portal <u>https://jkbank.abcprocure.com/</u> which is generally free of charge. During the enrolment, the bidders should provide true and correct information.
- b. Bidders need to login to the site through the user ID/ Password choosen during enrolment/Registration.
- c. Bidder need to go through the tender published on the site <u>https://jkbank.abcprocure.com</u>/ and https://jkbank.net/ and download the same.
- d. Bidder can use any query before the last date of the response Pre Bid Queries. They should also take notice of any corrigendum if any. Timelines will be communicated accordingly.
- e. It is construed that the bidder has read all the terms and conditions before submitting their offer. Bidder should go through the tender schedules carefully and upload the documents accordingly.
- f. Bidder should in advance get ready to upload documents in the format permissible.
- g. Bidder should submit the tender fee as specified in the Tender Document itself.
- h. While submitting the bids online, the bidder reads the terms and conditions and accepts the same to proceed further to submit the bids.
- i. The bidder has to upload all the documents as indicated in the tender document.
- j. The bidders are requested to submit the bids through online e-tendering system well before the bid submission end date and time. The Bank shall not be responsible for any sort of delay and difficulties faced during the online submission of bids.
- k. The time settings fixed on the server side and displayed on the tender site shall be valid for all actions of bid requesting, bid submission, bid opening etc. The bidders shall follow these timelines during bid submission.
- 1. For any queries, the bidders are requested to contact the concerned as given in the tender document
- m. Technical bid & Financial bid should be uploaded separately otherwise bid will be summarily rejected.  $$6\,|\,12$$



#### SCOPE OF WORK AND TERMS AND CONDITIONS

### SCOPE OF WORK

- 1. The Jammu and Kashmir Bank ltd intends to award annual contract for supply of bottled drinking water for use in its office located at Corporate Headquarters M.A.Road Srinagar. The Bank is looking for reputed firms/companies having adequate familiarity/experience in the field. The expected requirement of 20 (Twenty) litre water jars may be about 1100 bottles per month. However this may vary as per need. Participating firms/companies may furnish their quotes strictly as per Annexure-C.
- 2. The contract will be awarded for a period of One year.

#### TERMS AND CONDITIONS

- Earnest Money Deposit (EMD)/Security Deposit: The bidder is required to submit Earnest Money Deposit of Rs.30000/-(Rupees Thirty Thousand only) in the specified account. The security deposit of successful bidder shall be retained by the bank as performance guarantee and same shall be refunded to the successful bidder after the expiry of the contract. The bid security of the unsuccessful bidder will be discharged/returned to them with\_\_\_\_\_ days after finalization and award of contract without any interest. The same shall carry no interest.
- 2. The bidder shall not assign or outsource the works undertaken under this RFP assignment awarded by the Bank.
- 3. Bidder will, by responding to this RFP deemed to have accepted the terms of the RFP.
- 4. The Earnest Money deposit (EMD) will be forfeited by the bank:
  - a) In case of breach of any of the terms and conditions of RFP
  - b) Withdraws RFP at any time before the award of the contract
- 5. All costs and expenses incurred by interested bidders in any way associated with the development, preparation and submission of responses including but not limited to the attendance at meetings, discussions etc. and providing any additional information required by the bank, will be borne entirely and exclusively by the bidder.
- 6. It is required that bidders observe the highest standard of ethics during procurement and execution of the contract and not to indulge in any corrupt and fraudulent practice. The Bank reserves the right to reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- 7. Force Majeure-The selected bidder shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if any to the extent that its delays in performance or other failure to perform its obligation under this contract is the result of an event of force majeure.

For the purpose of this clause, Force Majeure means an event beyond the control of the contractor and not involving the contractors fault or negligence and not



foreseeable. Such events may be due to but are not restricted to wars, riots, earthquakes, fire, epidemic, quarantine restrictions, any act of god, act of god of India, trade embargos or any other such cause, which is beyond the reasonable control of the party.

The party claiming benefit of force majeure shall however not be entitled to the same unless it has intimated the other party of the occurrence of such an event within five working days from the occurrence of such force majeure event indicating therein the steps that it is taking or intending to take to mitigate the effect of such force majeure on the performance of his obligation under this agreement and shall continue to perform its obligation under the contract as far as reasonably practical and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

Notwithstanding above, the decision of the bank shall be final and binding on the contractor regarding termination of contract or otherwise.

- 8. Bank reserves the right to:
  - a) Reject the proposals received in response to the RFP containing any deviation.
  - b) Extend the time for submission of proposal.
  - c) Modify the RFP document, by an amendment that would be notified on the Banks Website.
- 9. Bid validity- the bid shall remain valid for a period of 120 days after the date of opening of bid proposal. In exceptional circumstances, bank may solicit the bidders consent for extension of the bid validity period. When the validity period is extended by the bidder, the same shall be done without any modification to the bid proposal by the bidder.
- 10. After the completion of bidding process, the successful bidder will be required to sign an agreement with the bank wherein all the terms and conditions governing the parties will be mentioned.
- 11. The Bank will be within its rights to ask the bidder to furnish any document at any point of time during technical evaluation and failure on the part of bidder to do so may lead to rejection of his bid.
- 12. The contract will be awarded for a period of One year.
- 13. The quality of water should be as per the terms of BIS/ISO.The average consumption of water may vary as per the actual consumption of water on day to day basis.
- 14. No security deposit will be deposited with the firm/company by J&K bank for jars supplied.
- 15. The water should be supplied on all working days at J&K Bank as directed by the J&K Bank, at the cost and risk of the firm/company. No extra payment will be made for this purpose. The firm/company should also be in a position to supply water at a short notice as and when required.
- 16. The person deputed for supply of water should be duly authorized by the firm/company.
- 17. The firm/company should ensure that the supply voucher is signed by the designated officer/officials on daily basis.
- 18. Prices quoted should be inclusive of delivery and handling charges. The price quoted will remain fixed throughout the contract period however in case of any changes made in taxes/levies by the government, the prices will change subject to constant base prices.

- 19. The seal of the jar should be maintained as per BIS/ISO norms for Servine packaged drinking water. Documentary proof for the same is to be attached with the bid.
- 20. The packaging/label of the jar should preferably have a scannable QR Code.
- 21. The firm/ company should provide in house and out house lab test reports on quarterly basis.
- 22. Mandatory submission of water testing report from a NABL (National Accreditation Board for Testing and Calibration Laboratories) accredited lab or any government approved laboratory
- 23. Mandatory submission of a self-declaration by the bidder/firm confirming that it is not classified as NPA by any financial institution.
- 24. The bidder shall ensure that only properly disinfected, sterilized and clean bottles are used and worn out are replaced periodically in accordance with the relevant norms.
- 25. In the event of supplied drinking water found to be not meeting the BIS/ISO standards when sent for testing, the supplier firm/company will be debarred from participation in future tenders and the pending bills shall be held and the tender shall be cancelled. The Security deposit will also be forfeited.
- 26. Payment Schedule: Payment to the agency will be made on monthly basis after the receipt of the bills and the verification of the day to day supply receipts. No advance payment will be made under any circumstances.
- 27. Responsibility of the firm/company:
  - a) Tenders should be filled with neat, legible and correct entries both in figures as well as in words. Alterations, erasers and indistinct figures should be avoided. Any correction in the quoted words by the tenderers shall be made in ink only and shall be signed by the <u>tenderer/authorized person</u>.
  - b) The submission of tender by a tenderer implies that he had read this notice and the terms and conditions of the contract and has made himself/herself aware of the scope and specifications of the work to be done and of the local conditions of the work place.
- 28. J&K Bank does not bind itself to accept the lower-bid or to give reasons for its decisions. The J&K bank reserves the right to reject any or all of the tenders received without assigning any reason thereof.
- 29. J&K Bank reserves the right to cancel/withdraw the present tender at any stage without assigning any reason thereof.
- 30. The Courts at Srinagar shall have exclusive jurisdiction. In case of any dispute, same shall be resolved amicably and in case such mutual amicable solution is not worked out within one month by the parties, then same shall be referred to Arbitration. Sole arbitrator shall be appointed by the Bank and the cost of arbitration shall be borne by Successful bidder and Bank equally.
- 31. Reverse Auction shall be conducted.

- 1. Financial bids of only those bidders whose technical bids are acceptable /qualified will be opened.
- 2. Tender Fee (non-refundable) of Rs.500 (Five Hundred Only).
