#### (v) GENERAL CONDITIONS OF CONTRACT

#### 1. Extent of Contract

The contract comprises the construction, completion & maintenance of the works & except in so far as the contract otherwise provides, the provision of all labour, materials, constructional plant, temporary works & everything whether of a temporary or permanent nature required in and for such construction, completion & maintenance so far as the necessity for providing the same is specified in or reasonably to be inferred from the contract.

#### 2. Letter of Intent / Acceptance / Award

Before signing of the contract, the Bank may issue by registered post or by otherwise, depositing at the registered office of the contractor, letter of Intent/Acceptance to enter into a contract with the contract for the execution of the works in accordance with the contract. Upon issue of such Letter of Acceptance / Intent by the Bank, the Bank shall be deemed to have signified his intention to award the contract, however, the process shall be deemed to be complete only when the contract has been entered into by the Bank & the contractor. However, until a formal contract agreement is prepared & executed, the tender together with the Bank's letter of intent shall constitute a binding contract between the parties, provided the Security Deposit as required under the contract shall have been furnished by the contractor.

#### 3. Contract Agreement

Within 10 days after the issue of letter of acceptance, the contractor shall have to enter into a written deed of agreement incorporating all the terms & conditions as embodied in the Tender Documents or modified subsequently in writing and those contained in the letter of acceptance, with the Bank. The contractor shall not sub-contract the work without written permission of the Bank.

#### 6. Contractor's General Responsibilities

The contractor shall, subject to the provisions of the contract, and with due care & diligence, execute, complete & maintain the works & provide all labour including Supervision, materials, constructional plant & all other things, whether of a temporary or permanent nature, required in and for such execution, completion & maintenance so far as the necessity for providing the same, excluding those to be provided by the Bank is specified in, or is reasonably to be inferred from the contractor. Temporary electric, water charges & any other extra charges shall be paid by the contractor & nothing shall be paid by the Bank.

The contractor shall carry out and complete and maintain the works in accordance with accepted good engineering practices and using materials and workmanship of the quality and standards therein specified provided that where and to the extent that approval of the quality of materials or of the standards of workmanship is a matter of option, such quality & standards shall be to the satisfaction of the Bank or Engineer in Charge or his Representative.

#### 7. Safety of Site Operations

The contractor shall take full responsibility for the safety, stability and adequacy of all site operations and methods of construction including all temporary works, provided that the contractor shall not be responsible, except as may be expressly provided in the contract, for the design or specification of the permanent works.

#### 8. Absence of Specification

If the specifications do not contain particulars of materials and works which are obviously necessary for the proper completion of the works, and the intention to include, which is inferred, all such materials and works shall be supplied and executed by the contractor without extra charge. If the contractor requires additional information, he shall, so request in writing, well in advance to commencement of the particular work, to the Engineer Incharge who will issue such detailed information as necessary within a reasonable time.

If, however, during the execution of the works, the contractor shall encounter physical conditions or obstructions constituting Force Majeure and which could not have been reasonably foreseen by an experienced contractor, the contractor shall forthwith give written notice thereof to the Engineer In Charge / Engineer's representative within two weeks after its occurrence and if in the opinion of the Engineer In Charge, such conditions or obstructions until so instructed by the Engineer In Charge except in the event of there being an urgent need to undertake remedial or other works or repairs to reduce risks of injuries or damages to persons or property.

#### 9. Obtaining Information related to execution of work

No claim by the contractor for additional payment will be entertained which is consequent upon failure on his part to obtain correct information as to any matter affecting the execution of the works nor will any misunderstandings or the obtaining of incorrect information or the failure to obtain correct information relieve him from any risks or from the entire responsibility for the fulfillment of the contract.

#### 10. Work to be to the satisfaction of Bank

The contractor shall execute, complete and maintain the works in strict accordance with the contract to the satisfaction of the Bank & shall comply with and adhere strictly to the Engineer's instructions and directions on any matter (whether mentioned in the contract or not) touching or concerning the works. The contractor shall take instructions and directions only from the Engineer. All execution of works & materials should be as per tender specifications. Materials for which specification is not given in tender in that case prior approval from the bank. Contractor is strictly advised not to use sub standard materials. And if any sub standard material is used or found then a penalty of two

times the difference in cost of standard material less sub standard material must be collected from the vendor/ sub contractor. i.e.; Penalty= 2x (Cost of Standard Material- Cost of Sub Standard Material) or bank have the right to hold the cost of that particular item and entire amount of the project will not be paid.

#### 11. Night or Sunday Work

As the site is in a crowded market, keeping in view the sensitivity of the site, the contractor can be asked to do the work at night, by special order, the contractor would be required to carry out the work at night, without conferring any right on the contractor to claim extra payment for night working. The decision of the Engineer in charge in this regard will be final and binding on the contractor.

#### 12. Corrupt and Fraudulent practice.

- It is required that Bidders observe the highest standard of ethics during the procurement and execution of such contracts and not to indulge in any corrupt and fraudulent practice.
- "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of an official in the procurement process or in contract execution.
- "Fraudulent Practice" means a misrepresentation of facts in order to influence a procurement
  process or the execution of contract to the detriment of the Bank and includes collusive practice
  among Bidders (prior to or after bid submission) designed to establish bid prices at artificial noncompetitive levels and to deprive the Bank of the benefits of free and open competition.
- The Bank reserves the right to reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- The Bank reserves the right to declare a Bidder ineligible, either indefinitely or for a stated period of time, to be awarded a contract if at any time it becomes known that the firm has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

#### 13. Liquidated Damages:

Should the work not be completed to the satisfaction of the Site Engineer within the stipulated period due to Contractors default, the contractor shall be bound to pay to the Bank, a sum calculated as below by way of liquidated damages and not as penalty during which the work remains uncommenced or unfinished after the expiry of the completion date.

If the contractor fails to complete the work by the scheduled date of completion or within any sanctioned extended time, he will have to pay liquidated damages at rate of 0.5 % of the contract value for each week of delay subject to maximum of 10 % of the contract value.

#### 14. Force Majeure:

- i. The Selected Bidder shall not be liable for forfeiture of its performance security, Liquidated damages or termination for default, if any to the extent that its delay in performance or other failure to perform its obligations under the contract is the result of an event of Force Majeure.
- ii. For purposes of this Clause, "Force Majeure" means an event explicitly beyond the reasonable control of the Contractor and not involving the contractors fault or negligence and not foreseeable. Such events may be due to or as a result of or caused by act of God, wars, insurrections, riots, earth

quake and fire, revolutions, civil commotion, floods, epidemics, quarantine restrictions, trade embargos, declared general strikes in relevant industries, satellite failure, act of Govt. of India, events not foreseeable but does not include any fault or negligence or carelessness on the part of the parties, resulting in such a situation. In the event of any such intervening Force Majeure, either party shall notify the other in writing of such circumstances or the cause thereof immediately within five calendar days.

- ii. Unless otherwise directed by the Bank in writing, the selected contractor shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- iv. In such a case the time for performance shall be extended by a period(s) not less than duration of such delay. If the duration of delay continues beyond a period of three months, the Bank and the contractor shall hold consultations in an endeavor to find a solution to the problem.
- v. Notwithstanding above, the decision of the Bank shall be final and binding on the contractor regarding termination of contract or otherwise."

#### 15. Available Bid Capacity/Financial Capability:

The bidder should possess the bidding capacity as calculated by the specified formula. The formula generally used is:

Available bid capacity =  $(A \times M \times N)$  - B, where

A = Maximum value of engineering (Civil/ Electrical/ Mechanical as relevant to work being procured) works executed in any one year during the last five years (updated at the current price level), taking into account the completed as well as works in progress.

M = Multiplier Factor (usually 1.5)

N = Number of years prescribed for completion of the work in question.

B = Value (updated at the current price level) of the existing commitments and ongoing works to be completed in the next 'N' years.

All costs and expenses incurred by interested bidders in any way associated with the development, preparation and submission of responses, including but not limited to the attendance at meetings, discussions etc. and providing any additional information required by the Bank, will be borne entirely and exclusively by the Bidder.

#### 16. Electronic Reverse Auction.

The said work shall be put to electronic reverse auction before opening of the financial bids.

Electronic Reverse Auction is a type of auction where the starting price, bid decrement, duration of auction, maximum number of automatic extensions are announced before start of online reverse auction. The shortlisted bidders shall after the start of RA start bidding online in an iterative process wherein the lowest bidder at any given moment can be displaced by an even lower bid of a competing bidder, within the duration of the RA. If a new lower bid is received within last few minutes (say two minutes) of closing time, the closing time may get automatically extended by few minutes (at least five minutes) for others to respond. Maximum number of such extensions may be stipulated (at least five). The most favorable bid at the end of stipulated/extended time will be declared as successful. The Reverse Auction shall be scheduled for a fixed time period. Auctions may be arranged in any

combination of time periods for e.g. (a) 1-1/2 hour viz. 1 hour with 6 extensions of 5 minutes each or (b) 1 hour viz.1/2 hours with 6 extensions of 5 minutes each or (c) Unlimited extensions viz. 1/2 hour with unlimited extensions of 5 minutes each.

All the price bids (Indicative bids) submitted by the vendors shall be kept sealed to the event of ereverse auction. At the end of reverse auction process the lowest Bidder (L1) will be selected on the basis of Total Price, including taxes.

In case the Prices arrived after Reverse Auction are more than the Indicative prices of any of the vendors, The Lowest Indicative prices of the vendor shall be considered and that vendor shall be declared the Lowest Bidder.

Bidding Example:

The final rates of the items shall be calculated in ratio of total amount quoted by the lowest bidder through reverse auction process and the amount quoted in indicative price bid, wherever specified in tender.

- **17.** After execution of the agreement with the successful bidder the relation of parties will be on principal to principal basis.
- **18.** The Bidder shall not assign or outsource the works awarded by the Bank without the written consent of the Bank.
- **19.** The successful bidder shall indemnify and keep J & K Bank, its Officers, Directors, employees indemnified in respect of any loss, damage or claim howsoever arising out of or related to breach of contract, statuary duty or negligence by the firm or its staff, agents in relation to the performance or otherwise of the services to be provided under the contract.
- **20.** <u>Dispute resolution/arbitration:</u> In the case of any dispute arising upon or in relation to or in connection with this agreement between parties, the disputes shall at the first instance be resolved through negotiations. If the dispute cannot be settled amicable within fourteen (14) days from the date on which either party has served written notice on the other of the dispute then any party can submit the dispute for arbitration under arbitration and conciliation Act, 1996. The sole Arbitrator

shall be chosen by the bank.

The Place of Arbitrations shall be Srinagar/Jammu, India and the language of the arbitration proceedings and that of the documents and communication between the parties shall be English.

The Decision of the Arbitrator shall be final and binding upon the parties. The expenses of the arbitrator as determined by the arbitrator shall be borne equally.

The parties shall continue to be performing their respective obligation under this Agreement, despite the continuance of the arbitration proceedings, except for the disputed part under arbitration.

- **21.** Each Bidder having responded to this NIT acknowledges to have read, understood and accepts the selection & evaluation process mentioned in this NIT documents. The bidder ceases to have any option to object against any of these processes at any stage subsequent to submission of its responses to this NIT.
- **22.** All Notices or Communications under this software maintenance Agreement shall be first sent to Email to such e mail addresses designated by each party, followed by registered post with acknowledged, where appropriate and required, to the address of each party first written above. A successful e mail delivery shall be treated as sufficient and complete delivery of the notice or communication. A notice by post will be sent by registered post acknowledge to the address set forth below, or such other address as it shall hereafter designate for this purpose:

In the case of a notice to contractor: email address registered with the bank.

Such notices shall be deemed to be received within four working days of the same being sent.

- 23. Bank reserves the right to select the next ranked bidder, if after selection the selected bidder withdraws his offer or bank detects wrong or misleading information in the proposal, In case the selected bidder withdraws his offer or if it is found that the information furnished by the bidder is wrong and misleading. Bank reserves right to take action as it deems fit, including forfeiture of EMD, claim for damages against the bidder.
- 24. Labour License: All the Bidders must necessarily possess a valid Labour license (if applicable) obtained from concerned Govt. labour department. The said license is necessary for executing contract works under relevant provisions of different laws for the time being in force including but not limited to the Contract Labour (Regulation & Abolition) Act, 1970. It may be noted that no work order/Allotment shall be issued to the lowest bidders not submitting the relevant labour license.
- 25. Security Deposit: No EMD is to be submitted with the tender documents. However, this being a limited tender among the already empanelled agencies, the agency quoting the lowest bid has to submit a security deposit of 2 % of the bid amount for a particular work. The security deposit shall be retained till the empanelment is valid or defect liability period of the particular work, whichever is later. Pertinently, an agency getting multiple works through the tendering process shall have to deposit security deposit for every work, subject to a maximum aggregate ceiling kept by the Bank for a particular category an agency is empanelled in. All other terms and conditions not covered but in vogue in the CPWD shall hold good and form a part of the e-NIT.
- **4.** No advance payment in the form of site mobilization advance, material advance etc. will be paid to Contractor. Running payments will be released after satisfactory completion of the portion of the works and measurement.
- **5.** All other terms and conditions not covered but in vogue in the CPWD shall hold good and form a part of the e-NIT.
- 6. In the event of contract failure Bank reserves the right to terminate the contract after giving 20 days clear notice to the contractor and recover the amount of the loss caused by the damage, failure, default (including the consequently damage) as may be determined by The Vice President J&K Bank or his authorized representative.
- 7. The contractor shall provide company warranty cards of various items installed during the execution of work. Final bills shall be processed only after submission of the same.

4.2 Inside conditions (C.H)  $22.0^{\circ}$  C DB  $\pm 1^{\circ}$  C

4.3 Fresh Air 1.0-air changes per hour.

4. <u>Estimated requirement:</u>

The estimated heat load of the area, proposed to be heated shall be provided is as mentioned in BOQ.

- 5. <u>System design:-</u> SITC of Central heating system for BU Hazratbal 5.1
- 5.2 Installation of 01 No. Hot water generators, 01 No hot water circulation pump, 01 No day oil tank, flue gas chimney etc.
- 5.3 Building is heated by hot water radiators, Fan coil units imported wall mounted type/floor mounted type.
- Hot water from main boiler plant shall be supplied to these units using PPR (PN-20) class insulated piping.
- 5.5 Main boiler plant shall supply hot water to radiators/ FCUs and heating take place due to natural/ forced convection and due to hot air circulation.
- 5.6 Necessary electrical panel board with cabling.
- 6. <u>Test data</u>:- The plant whole system shall be tested as per specification given elsewhere and complete test data shall be furnished on prescribed data sheet.

## Specification of Equipment and Accessories of the Central Heating System.

#### 1. Hot water generator

- The hot water generator shall be fuel-efficient designed for energy saving and ecologically harmless low temperature operation.
- > The hot water generator should have a large combustion chamber in compliance with norms, perfect combustion, low emission ratio, efficient heating.
- The hot water generator should have stainless steel/M.S tabulators installed inside the combustion gas pipes to have maximum heat transfer coefficient.
- ➤ Boiler body shall be fully welded type, made of boiler steel, mono block casing. Burner shall be fully Automatic type. The pressure jet type Burner shall be designed for complete atomization of fuel to obtain total combustion.
- > The Burner assembly shall provide automatic modulating control of fuel combustion depending upon the load requirements.
- > The Hot water Generator shall be complete with mechanical draught, fan motor assembly, oil pumps, and pressure jet burner assembly with controls safety devices, gauges, thermostats and other necessary accessories.

#### 2. <u>Exhaust chimney</u>

- The hot water generator shall be provided with an independent flue gas chimney, which shall extend one meter beyond the top of the building.
- > The chimney shall be self-supporting and fabricated out of 3 mm thick M S plates.
- A bottom plate of 6 mm thick M S plate shall be provided to support the weight of the chimney.
- > The chimney shall be connected in the Boiler Exhaust through a flanged circular 3 mm thick plate section.
- The chimney shall be insulated with 50 mm thick glass wool duly covered with 24 gauge Aluminum sheet cladding.

#### 3. <u>Day oil service tank.</u>

- > The plant room shall be provided with one day oil service tank complete with inlet connection, outlet, drain and duly mounted on a suitable M S Angle iron frame at a higher location to provide gravity oil feed to the Boiler.
- > The tank shall be triple layer LLDPE type with triple layer and with inner coating conforming to IS 12701: 1996

#### 4 Piping

- > The Hot water piping shall be PPR PN 20.
- The piping shall be arranged and installed parallel or perpendicular to the walls or ceilings.
- Anchors and supports shall be provided wherever necessary to prevent any misalignment of piping.
- > The piping shall be tested prior its connection to equipment and applications. They shall be tested to hydraulic test pressure of net less than 10 kg/sqm for a period of 24 hours. All the leaks and defects so revealed in the piping shall be rectified.

#### 5 Drain piping

> Drain lines shall be provided at all the lowest points in the system as well as at the equipments where leakage of water is likely to occur or to remove condensate and water from pump glands. The drain piping shall be carried out with threaded joint only.

#### 6 Strainers

The strainers shall either be POT type or Y type with cast iron or fabricated steel body. Complete with a perforated Bronze sheet screen with 3 mm perforation, 0.63 thick. The strainers shall be provided with flanged construction.

#### 7 Hot water circulation pump.

- The hot water circulation pump shall be centrifugal Mono block type with suction and discharge flanged connections, with squirrel cage induction Motor. The pump shall be mechanical sealed type.
- > The electric motor shall be single phase operating on 220 volts ± 15% at 50 Hz ± 3% having class B insulation.
- > The pump and Motor mounted on a common base frame shall be laid on cement concrete foundation / Vibration Isolation pads with a G I sheeting in between two V I pad shall be provided under the cement concrete foundation. An additional steel channel base frame shall be provided between the cement concrete foundation and the pump motor base frame.
- > On installation the capacity of the motor current and pressure difference at inlet and outlet the reading shall be recorded to compare actual performance with specified data.

#### 8 <u>Expansion tank</u>

Expansion tank shall be of PVC make duly installed in attic with in let, out let, over flow and other necessary connections.

#### 9 Hot water radiator.

- The hot water radiator shall be fabricated out of high-grade steel. The radiators shall be highly efficient in terms of heat transfer. A powder coating shall follow high quality catephorsis stove enamel.
- All the radiators shall confirm to EN-442 standards.

#### 10 Insulation

- The insulation for hot water piping shall be resin bonded glass wool/ nitrile rubber. For glass wool type insulation the insulation shall be in the form of blanket of uniform thickness factory laminated of density of 32 kg /m³ and k value of 0.028 k cal /hr/m³ c at 10° C mean temperature confirming to IS 8183.or pipe section type in case of nitrile foam of thickness as per industry standards.
- In case of glass wool insulation, the insulation shall then be covered with 0.63 mm x 20 mm mesh wire netting; Finally 12 mm thick cement sand plaster in two coats of 6 mm each shall be applied in such a way that a smooth round finish is achieved, and where pipe is exposed shall be covered with 24 G aluminum foil or as directed by Engineer Incharge.
- For nitrile rubber insulation, the density of the material has to be in the range 40-60 Kg/cum and thickness not less than 12mm (thickness varies as per Outer dia of the pipe).

<u>Pipe size</u> <u>Thickness of insulation</u>

10 mm to 25 mm 25 mm 50 m to 100 mm 50 mm

#### 11 Electrical work

The electrical work shall include cabling from service line to plant room, one incomer having suitable ampere rating MCCB with magnate thermal releasing out goings for hot water boilers and hot water circulation pumps, with suitable DTC.



## **Testing**

- 1) In general, tests shall be applied to piping before connection of equipment and appliances. In no case shall the piping, equipment or appliances be subjected to pressure exceeding their test rating.
- 2) The tests shall be completed and approved before any insulation is applied. Testing of segments of pipe work will be permitted provided all open ends are first closed, by blank offs or flanges.
- 3) After tests have been completed the system shall be drained and flushed 3 to 4 times and cleaned of all dust and foreign matter. All strainer valves and fittings shall be cleaned of all dirt fillings and debris.
- 4) All piping shall be tested to hydraulic test pressure of at least one and half times the maximum operating pressure but no less than 10 kg/ sqm for a period of not less than 24 hours. All leaks and defects in the joints revealed during the testing shall be rectified to the satisfaction of the engineer in charge without any extra cost.
- 5) All piping systems shall be tested in the presence of the engineer in charge or their authorized representative. Advance notice of test dates shall be given and all equipments, labour, materials, required for inspection, and repairs during the test shall be provided by the contractor. A test shall be repeated till the entire systems are found to be satisfactory to the above authority. The test shall be carried out for a part of work if required by Engineer Incharge in order to avoid hindrance in the work of other contractor.
- 6) The contractor shall make sure that proper noiseless circulation is achieved through all piping systems. If due to poor bond, proper circulation is not achieved, the contractor shall bear all expenses for carrying out the rectification work including finishing of floor, walls and ceiling damaged in the process of rectification.
- 7) The contractor shall provide all labourers and materials to make provision for removing water and throwing it at the proper place, during the testing or / and after the testing to avoid damages to employer or other contractors' properties. Any damages caused by the contractor to the employer or other contractors' properties, shall be borne by the contractors.
